PROGRAM EMPHASIS

Current issues of law and policy receive special emphasis, as do interdisciplinary features such as economic, cultural and historical factors. All legal aspects are compared to the Ukrainian legal system. A special emphasis is put on the enterprises' legal position, when doing business in the European Internal Market and internationally.

ADMISSION REQUIREMENTS

Admission requirements are a first law degree/diploma (LLB, JD etc) or another degree/diploma of a program with a substantial legal education. Non-native speakers must prove their good knowledge of English (e.g. TOEFL, IELTS), or undertake our preparatory course to improve their level of English.

- If any of the High Contracting Parties should be the object of an armed attack in Europe, the other High Contracting Parties will, in accordance with the provisions of Article 51 of the Charter of the United Nations, afford the Party so attacked all the military and other aid and assistance in their power.
- 23 October 1954 amended by Paris Protocol which added West Germany and Italy to the Western Union Defence Organisation.

MARCH 2016 – JULY 2016

The project group of master's program continued to work on bringing the activity of project group on master's program and all the documentation into compliance with the license conditions regarded in the Cabinet of Ministers of Ukraine Regulation of 30 December 2015 (new license conditions of providing educational services).

The project group of master's program developed a strategy for dissemination of information about the master's program and its advertising.

The project group conducted information activities among the bachelors.

The project team helped others project group of the university in their efforts to develop other bachelor's programs and master's programs. The work on syllabuses was continued in accordance with new requirements and educational content of modules (academic disciplines, practices) of the master's program

AUGUST 2016 – OCTOBER 2016

Revised the profile of the Master's program (reduced the size of the program to 105 ECTS, reduced the period of training under the program of up to 1 year and 6 months, reduced the list of disciplines, revised curriculum)

Completed work on preparation of working programs of courses (syllabus), educational content (presentations), training and methodological support of courses.

Made a new information website of master's program

Developed recording regulations on selective courses of the program, developed a form of a recording on selected courses and held record students on selected courses of master's program.

Organized a permanent survey of students on the quality of education.

NOVEMBER 2016 – FEBRUARY 2017

Revised the profile of the Master's program for next (2017-2018) educational year (reduced the size of the program to 90 ECTS, reduced the period of training under the program of up to 1 year and 4 months, reduced the list of disciplines, revised future curriculum)

Continued work on actualisation of course's working programs (syllabus), educational content (presentations), training and methodological support of courses.

Continued informational activities among undergraduate students, started to a preparation of entrance examinations and selection of students, evolved an information website of master's program <http://intereulaweast.onua.edu.ua> and the new website of master's program <https://sites.google.com/onua.edu.ua/intereulaweast>.

Conducted the first examination session on the program in December.
